**Requirements and information:**

- All applications must be accompanied by proof of lawful presence in the U.S.
- Program applies to RWSD account customers in good standing
- Those customers living in a multi-family dwelling served by RWSD are also eligible
- Rebates are only given for washers meeting the criteria of the Consortium for Energy Efficiency (CEE) for High Efficiency (HE), [www.ceel.org](http://www.ceel.org), clothes washers
- Washer must be installed in an RWSD water account residence
- Limit one washer rebate per RWSD water account address
- The rebate amount cannot exceed the actual cost of the washer
- An inspection may be required to verify the replacement of your washer
- A rebate check will be issued within six (6) weeks of approval of rebate application
- To qualify for the program, your receipts needs to be dated between 1/1/08 and the end of the program year. Rebate program is first come, first served. Limited funds are dedicated for the program each year. When funds are exhausted, the program ends
- Customers must have a copy of the original receipt

## Roxborough Water and Sanitation District's Rebate Requirements

House Bill 06S-1023, signed into law by Governor Bill Owens on July 31, 2006, restricts who may receive public benefits in the State of Colorado. Anyone 18 years of age or older must prove lawful presence in the United States in order to receive non-emergency public benefits.

This law applies to Roxborough Water and Sanitation District's Rebate Programs. In order to apply for a rebate, we require the additional submission of the **Affidavit of Lawful Presence in the United States** with a copy of one form of identification as described below:

\*a valid Colorado driver's license (includes only a *current* driver's license, minor driver's license, probationary driver's license, commercial driver's license, restricted driver's license, or instruction permit),

Note: The Colorado Department of Revenue allows us to accept a driver's license from the District of Columbia and the following states: Alabama, Arizona, Arkansas, California, Connecticut, Delaware, Florida, Georgia, Idaho, Indiana, Iowa, Kansas, Kentucky, Louisiana, Maine, Minnesota, Mississippi, Missouri, Montana, Nevada, New Hampshire, New Jersey, New York, North Dakota, Ohio, Oklahoma, Pennsylvania, Rhode Island, South Carolina, South Dakota, Virginia, West Virginia, and Wyoming.

- \*a valid Colorado identification card,
- \*a valid United States passport,
- \*a United States military card,
- \*a United States military dependent's identification card,
- \*a United States Coast Guard Merchant Mariner card,
- \*a Native American tribal document,
- \*a naturalization or citizenship certificate.

Submit the completed affidavit and your copied identification with the other required rebate paperwork. Your identification materials are not considered public record and will remain confidential.

**Affidavit of Lawful Presence in the United States**

**Required by Roxborough Water and Sanitation District's  
Rebate Applications**

I understand this sworn statement is required by law because I have applied for a public benefit. I understand that state law requires me to provide proof that I am lawfully present in the United States prior to receipt of this public benefit. I further acknowledge that making a false, fictitious, or fraudulent statement or representation in this sworn affidavit is punishable under the criminal laws of Colorado as perjury in the second degree under Colorado Revised Statute 18-8-503 and it shall constitute a separate criminal offense each time a public benefit is fraudulently received.
